ARTICLES OF INCORPORATION
OF
THE LINCOLN SPRING FLING, INC.

The undersigned hereby associate to establish a nonprofit corporation under the provisions of the Nebraska Nonprofit Corporation Act of the State of Nebraska, and pursuant thereto make, execute, and acknowledge Articles of Incorporation as follows:

ARTICLE I

Section 1. The name of the Corporation shall be the Lincoln Spring Fling, Inc., and the duration shall be perpetual.

ARTICLE II

Section 1. The purpose of the Corporation is to enjoy sobriety and to carry out the message of sobriety to still suffering alcoholics.

Section 2. The Corporation shall undertake such charitable, educational, civic, and social activities as are appropriate to its purpose, including the distribution of gifts to appropriate organizations.

ARTICLE III

Section 1. The duration of the Corporation shall be perpetual.

ARTICLE IV

Section 1. The principle office of the Corporation shall be 1100 South 22nd Street, Lincoln, Nebraska 68502 and its registered agent shall be Wayne Anderson.

ARTICLE V

Section 1. The affairs of this organization shall be managed by a Board of Directors consisting of seven Directors.

Section 2. The initial Board of Directors shall be:

Section 4. Each Director shall be a person who is currently sober and has been sober for at least two years, and sobriety for two years immediately preceding Board membership is a condition precedent to membership on the Board of Directors.

Section 5. The Directors shall be elected by the members of the Corporation.

Section 6. The Directors shall be elected for three year terms except that (a) two of the first Board of Directors shall be elected for a term of one year, two of the first Board of Directors shall be elected for a term of two years, and three of the first Board of Directors shall be elected for a term of three years, and (b) Directors elected to fill a vacancy shall be elected to serve for the remainder of the unexpired term.

ARTICLE VI

Section 1. The members of the Corporation may adopt such By-laws for the government of the Corporation, consistent with these Articles of Incorporation, as are designed to carry out the purpose of the Corporation.

Section 2. By-laws may be adopted, amended, repealed, or added to by a majority vote of the members of the Corporation present at any meeting of the Corporation.

ARTICLE VII

Section 1. These Articles of Incorporation may be amended in the manner provided by law. However, an amendment must be authorized by a majority of the members of the Corporation present at an annual meeting or a special meeting called for the purpose of considering any such proposal. Any proposed changes to the Articles of Incorporation shall be sent to the members at the time the notice is sent of any special meeting in which proposed changes are to be considered.

ARTICLE VIII






Section 1. In the event of the dissolution of this corporation, any remaining assets shall be distributed as follows:

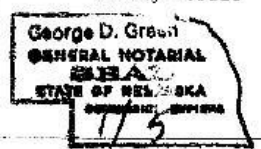
