

**AMENDED ARTICLES OF INCORPORATION OF
THE LINCOLN SPRING FLING, INC.**

The undersigned hereby amend the Articles of Incorporation filed October 1, 1986 in the State of Nebraska as follows:

ARTICLE I

The name of the Corporation shall be Lincoln Spring Fling, Inc.

ARTICLE II

The duration of the Corporation shall be perpetual.

ARTICLE III

This Corporation is a Public Benefit Corporation.

ARTICLE IV

The principle office of the Corporation shall be the address of the Registered Agent.

ARTICLE V

The affairs of this organization shall be managed by a Board of Directors consisting of a minimum of seven (7) Directors and a maximum as specified by the Bylaws.

ARTICLE VI

In the event of the dissolution of this Corporation, any remaining assets shall be distributed as follows:

60% to the Lincoln Alcoholics Anonymous Central Service Office

30% to the Alcoholics Anonymous General Service Office, New York, NY

10% to the Nebraska Alcoholics Anonymous Area 41

ARTICLE VII

SECTION I: The purpose of the Corporation is to carry the message of sobriety to the still suffering alcoholic.

SECTION II: The Corporation may undertake such charitable, educational, civic and social activities as are appropriate to its purpose, including the distribution of gifts to appropriate organizations.

ARTICLE VIII

SECTION I: The Directors of the Corporation may adopt such Bylaws for the governance of the Corporation, consistent with these Articles of Incorporation, as are designed to carry out the purpose of the Corporation.

SECTION II: Bylaws may be adopted, amended, repealed or added to by a majority vote of the Directors of the Corporation, which must be present at any meeting of the Corporation.

ARTICLE IX

The Corporation shall be solely responsible for all debts and liabilities of the Corporation, and may not hold any Board member responsible for any debt and liabilities of the Corporation.

ARTICLE X

These Articles of Incorporation may be amended in the manner provided by law and by the Corporation Bylaws by two-thirds of the Directors of the Corporation at any meeting of the Corporation.
